**Proposed  
Constitutional Amendments**

**Question 1**

# **Voting Guidelines**

## **Voting Requirements:**

- Be registered to vote in Virginia.
- Be a US citizen
- Be 18 by Election Day, November 8
- Reside at a Virginia address
- Not be convicted of a felony, unless your voting rights have been restored
- Not currently judged incompetent by a court

## **In-person ID requirements:**

- A Virginia driver's license or Photo ID
- A Veteran's ID from Virginia DMV
- US Military ID
- A US Passport
- A student ID issued by a Virginia college or private school

## **Voting in Person:**

- Early Voting: Sept. 23-Nov. 5
- Vote on Election Day, Nov. 8

# Hillary Clinton

## Education:

- Supports modernization of the teaching profession
- Supports the rebuilding of educational facilities
- Proposes that families making \$85,000 or less can attend an in-state four-year public university or college tuition free
- Proposes the allocation of funds for students with children

## Jobs and Economy:

- Supports an economy that works for everyone
- Supports a \$15 federal minimum wage
- Supports a 12 week paid family and medical leave

## Healthcare:

- Supports incentives for states to help low income families receive health insurance.
- Supports women's access to preventive care, affordable contraception, and abortion
- Supports better access to affordable health care for all families, regardless of immigration status

- Supports tax reform
- Supports additional controls on spending
- Proposes an elimination of the income tax on businesses and employers
- Supports de-regulation

## Healthcare:

- Opposes the Affordable Care Act
- Supports state independence in Medicare and Medicaid
- Proposes a free market approach to healthcare
- Believes healthcare should have advertised pricing to keep it competitive
- Approves assisted suicide after a psychological examination

## Social Issues:

- Supports sending of aid for the Syrian refugee crisis
- Supports immigration for willing workers
- Supports background checks for work visas
- Opposes alien citizenship and green cards
- Supports term limits for governors and Congress

# Jill Stein

## Education:

- Supports free college education
- Supports elimination of all existing student loan debt
- Opposes standardized testing and public school privatization
- Proposes overhaul of Common Core educational standards
- Supports increase in federal funding for Public Schools



## Jobs and Economy:

- Proposes a change to 100% clean renewable energy by 2030
- Wants to invest in public transit, sustainable agriculture, and conservation
- Supports socialized banking and utilities
- Supports an increased tax rate on stock trades and large corporations.
- Opposes trade agreements such as

NAFTA, TTIP and TPP

## Healthcare:

- Opposes the Affordable Care Act
- Proposes an improved Medicare for all program
- Supports an increase in funding for low-income healthcare
- Supports Union and worker's rights
- Supports stronger label requirements by the FDA

## Social Issues:

- Proposes all illegal immigrants be given in state tuition pricing, scholarships and grants.
- Proposes an easy path for illegal immigrants to gain citizenship
- Proposes an increase in the amount of work visas given to immigrants.
- Accept more than 10,000 Syrian refugees.
- Supports federal funding for community programs that address health disparities in gender, race and income



# Evan McMullin

## Education:

- Supports reform for federal regulation of education and student aid
- Supports federal aid for students attending tech schools and work programs
- Supports regulation holding colleges accountable for high costs and low graduation rates
- Opposes Common Core standards
- Supports federal aid for K-12 students attending charter schools



## Jobs and Economy:

- Opposes a raise to the federal minimum wage
- Supports tax reduction for the middle class and small business
- Opposes incentives for business elite-political partnerships
- Supports stricter standards on federal regulatory agencies
- Supports stricter standards for social security and

Medicare

## Healthcare:

- Opposes the Affordable Care Act
- Supports reform in the federal funding of Medicaid
- Supports a uniform federal subsidy for senior health insurance or Medicare
- Proposes federal publication of insurance options for social security beneficiaries
- Opposes government subsidized abortions

## Social Issues:

- Supports immigration laws
- Opposes the legalization of marijuana
- Opposes gay marriage
- Supports streamlining in Department of Defense acquisitions
- Supports existing gun laws



# Proposed Constitutional Amendments

There are two amendments that will appear on the Virginia ballot in 2016.

The first is the “**Right to Work**” amendment. It will appear on the ballot as a question:

“Should Article I of the Constitution of Virginia be amended to prohibit any agreement or combination between an employer and a labor union or labor organization whereby (i) nonmembers of the union or organization are denied the right to work for the employer, (ii) membership to the union or organization is made a condition of employment or continuation of employment by such employer, or (iii) the union or organization acquires an employment monopoly in any such enterprise?<sup>[5]</sup>”

The current law states that any agreement between employer and member of a labor union is against public policy if nonmembers of the union denied their right to work. The employee has to be a member of the union to get or keep their job as declared by the employer, or the union acquires an employment monopoly.

Voting for this amendment would add section 11-A to the Virginia constitution stating it is illegal to require mandatory labor union membership. It would cost \$131,158 for providing public notice, but this fee will be paid for by State Board of Elections and have no impact financially on the Department of Labor and Industry. This amendment would not change any current law but just add

to Virginia citizen’s right to not be a member of a labor union.

The second proposed amendment is the **Virginia Property Tax Exemption for Surviving Spouses of Police and Service Personnel** amendment. It will appear on the ballot as a question:

“Shall the Constitution of Virginia be amended to allow the General Assembly to provide an option to the localities to exempt from taxation the real property of the surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel, or emergency medical services personnel who was killed in the line of duty, where the surviving spouse occupies the real property as his or her principal place of residence and has not remarried?”

The Virginia Constitution currently exempts any taxation of real property, including joint property of a spouse, of any veteran that has been permanently disabled on duty, as determined by the US Department of Veteran Affairs. It also exempts taxation of surviving spouses of members of the Armed Forces who were killed in action, as determined by the US Department of Defense. In both cases this exemption ceases if the spouse remarries.

Voting for this amendment would extend this exemption through section 6-B of the Virginia Constitution, extending it to spouses of police, firefighters, search and rescue, or emergency medical service personnel who expired on the job.

# Jane D. Dittmar

## Education:

- Supports promotion of computer access and training for people that cannot afford college
- Supports incentives to businesses who offer technical education in rural areas

- Supports enhanced scholarship funding for top students coming out of high school

- Opposes Medicaid



## Jobs and Economy:

- Supports deregulation of farming practices
- Supports lower federal taxes to create more jobs and economic growth
- Opposes an increase to minimum wage

## Social issues:

- Supports stronger immigration guidelines
- Opposes benefits and employment for illegal aliens
- Opposes acceptance of Syrian refugees
- Supports the border wall

The following question will appear on the ballot. The question addresses obligation bonds to fund improvements at Albemarle County school and reads as follows:

“Shall the County of Albemarle, Virginia, contract a debt and issue general obligation bonds in the maximum aggregate principal amount of \$35,000,000 for the purpose of providing funds, in addition to any other available funds, to finance the

costs of improvements to Albemarle County public schools including designing, building, expanding, and renovating school properties, including new buildings and additions, renovations, and improvements to existing buildings, installing new furnishings and equipment in the public schools, and the related costs to issue the bonds and to reimburse the County for temporary financing?
